

# **Amendment to the Articles of Incorporation of the West Sound Disc Golf Association**

## **Article 1**

The name of this corporation is the West Sound Disc Golf Association.

## **Article 2**

This corporation is a non-profit corporation and is not organized for the private gain of any person. The specific purposes for which this corporation is organized are to promote the sport of Disc Golf, maintain the local disc golf course(s) (by removing debris and trash, repair and replace course equipment); provide free and/or fee-based recreational opportunities to residents of Kitsap County and the surrounding region; provide a recreational outlet for youth; serve as an information and referral network to the public; provide private and community recreational resources; provide regular free and fee-based opportunities for friendly, non-threatening competition; provide assistance with sport skills, in both a written format and a hands-on teaching format; provide a space for other local groups.

## **Article 4**

(a) This corporation is organized and operated exclusively for the charitable purposes within the meaning of Section 501c3 of the Internal Revenue Code.

(b) Notwithstanding and other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (1) by corporation exempt from federal income tax under section 501c3 of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal revenue Code.

(c) No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of, or in opposition to, a candidate for public office.
