#### **Course Discussions**

#### N.A.D. Park DGC

Hole 1 has a downed tree half way down the fairway. Paul Wright will contact the City of Bremerton to request removal of the tree. Hole 8 could use a trimming of branches above red pad, Paul Wright will assess.

# **DISCovery DGC**

Course conditions are good. Dan Glynn is working with 360 Disc Golf to make signs for the footboards at each tee area. Dan brought the decals that the signs will be made out of and they look great. Scheduled completion date early Summer.

#### Kitsap Fairgrounds DGC

Course is looking good. It is Stinging Nettle season so be cautious.

Eagle Scout project to install four new benches on holes 2, 7,10,16 in the next month.

#### Bud Pell at Ross Farm DGC

Paul Wright completed the installation of the benches for the gold tee areas. Brian Johnson has the finished tee signs and is ready to install. A post hole digger will be rented to complete the project. Mowing season is in full swing and Paul Wright will begin regular mowing. OB lines will be realigned by Paul Wright as well. Teepads are due to be replaced on some of the Red Pads as a work party will be scheduled soon. There is a pair of nesting geese on hole 6 between the red tee pad and the blue tee pad. A barricade has been created to give the geese some privacy. We ask that the club members respect our feathered friends during this process. The other tee pads will re-open once the barricade has been removed.

#### Van Zee Park

Course is now open for play. Kiosk needs work. Tee signs are in need of an upgrade.

#### Horseshoe Lake Golf Course

The new "Canyon" course at Horseshoe Lake is open for play. The play opportunity is limited. Call for tee times. The original course is called the "Lakeside" course at Horseshoe Lake. Doubles will begin April 26th on Fridays. Bill Winkler is running the event at \$20 entry fee with green fees, cart rental, CTP, Ace Prize, and Payout included. The Ace Prize is \$500.

## **Old Business**

#### East Bremerton DGC

Paul Wright has drafted a disc golf course design to submit to the Bremerton School Board for approval. A multi-use path through the park is currently approved and we are certain the course design will accommodate the path throughout the disc golf course. Paul will display the map as soon as it is approved. The planning process is slow and the WSDGA should know more next Spring. Paul is really going to push to get it started. Pitch and putt? 9 holes?

# Battle Point Park DGC, Bainbridge Island

The Bainbridge Island Disc Golf Club wrote an excellent proposal to Washington State Team Golf League asking if they would like to fund new baskets for the park. Washington State Team Golf League approved this proposal and was happy to provide the park with upgraded new baskets. The old baskets will be available to use if the parks Board allows an additional 9 holes to be added to the disc golf course.

#### Deaf Disc Golf Nationals

Paul Wright was asked to be an assistant TD for the tournament. The dates for the event is August 1-3, 2019. The courses to be used for the event will be N.A.D. Park DGC and the Bud Pell DGC.

#### Insurance

Paul Wright stated that he will do more research and report back to the WSDGA Board.
